## **TERMS & CONDITIONS - READ CAREFULLY**

**STANDARD TOUR PRICE, RESERVATIONS & SCHEDULE of PAYMENTS**: Standard Adult Tour Price – **US\$5,800.00** per person in double accommodation. See Congress Brochure for package details. Reservations for this tour are confirmed upon receipt of your registration form and a deposit of US\$1000.00 per person, which is due on or before **NOVEMBER 25, 2025**. A second deposit of US\$1200.00 is due on or before December 23, 2024. A third deposit of US\$1200.00 is due on or before January 28, 2025. A fourth instalment of US\$1200.00 is due on or before March 28, 2025. Final payment is due on or before April 28, 2025.

**HOTEL ACCOMMODATIONS:** Hotel accommodations are based on double occupancy with private bath. **Participants without a roommate will have to pay the single room surcharge, which is US\$985.00** In this regard, with the participant's permission, every effort will be made to find an appropriate roommate, <u>wherever</u> possible.

**CANCELLATIONS & REFUNDS:** Deposits are refundable until January 28, 2025, minus US\$50.00 administrative fee. Cancellations between January 29, 2025 and April 28, 2025 will attract a surcharge of US\$500.00. **Cancellations as of April 29 are non-refundable and funds can only be recovered through a travel insurance policy.** Cancellations must be made in writing.

UNUSED SERVICES: No refunds will be made for unused tours, meals or any other program components.

**PASSPORT/VISA/VACCINATIONS:** A valid passport is required (as well as a visa for the United States and Australia). Each participant will be required to take the responsibility of applying for and securing such visa. Passports must expire no less than six (6) months after the proposed date of arrival in the United States. No vaccinations are required.

**FEES NOT INCLUDED**: Travel Insurance, visa fees, meals and beverages not specifically included in itinerary, items of personal nature, telephone, laundry and tour sites other than those mentioned, tips to tour guides and hotel staff are **NOT** included in your package cost and are for your own account.

**TRAVEL INSURANCE:** Travel Insurance is not included. It is the traveller's responsibility to secure coverage or to provide proof of same. You may contact the office for guidance if needed.

**TAXES & FEES INCLUDED:** All airport and hotel taxes as well as admission to all attractions in the tour itinerary are included.
